The OsunState Government, through the Ministry of Works, intends to carry out the rehabilitation of Palleluyah Estate - Delightsome Hotel - Niyi Ibikunle Farm Plantaintion Road, Osogbo and In compliance with the provisions of the Osun State Procurement Law 2012, the OsunState Ministry of Works, on behalf of the OsunState Government, hereby invites interested, eligible and competent Contractors to bid for the rehabilitation of Palleluyah Estate - Delightsome Hotel - Niyi Ibikunle Farm Plantaintion Road, in Osogbo the State Capital

2.0 SCOPE OF THE WORK

The scope of the work will include

- i. the scarification of existing pavement,
- ii. removal of unsuitable materials
- iii. c onstruction of hydraulic structures,
- iv. Earthworks
- v. Pavement and Surfacing
- vi. Road Furnitures and construction of new furnitures

3.0 ELIGIBILITY REQUIREMENTS

- g. Company average Annual Turnover of not less than Five Million Naira (N5,000,000

) **h.** Evidence of similar project executed (letter of award and completion certificate) at least three (3) in the last five (5) years.

- i. Verifiable evidence of company profile and technical qualification of key personnel registered with relevant professional bodies (COREN, CORBON, QSRBN, ARCON etc.)
- j. VAT registration and evidence of past remittance
- **k.** That the Company have fulfilled all obligations to pay taxes, pensions and social security contributions.
- I. A sworn affidavit certifying as follows:
 - i. That document submitted for pre- Qualifications exercise are not only genuine but correct
 - ii. That none of the directors of the company has been convicted by any Court of law
 - iii. That company is not Bankrupt
 - iv. That none of the officers of Osun State/Local Government is present or former Director of the company
- m. Any other relevant information that will help in determining the company's suitability for the work
- Any prospective bidder that does not possess any of the above documents need not to apply.
